WAIVER AND RELEASE OF CLAIM FOR DAMAGES

I, _____, (Contestant) acknowledge that Rodeo activities are inherently dangerous and create a substantial risk of damage to my personal property (including livestock and equipment) and of serious bodily injury (including death or permanent injury) to all participants as well as to others. I hereby represent and acknowledge that I am aware of these risks and that they cannot be completely eliminated even with the utmost care. I acknowledge that when participating, in any capacity, in the event by the NTA North America's Richest Indian Rodeo, the risk of these injuries is substantially increased, and I have a duty to use caution and diligence to reduce the risk of the injuries and damages mentioned above, I assume the risk of any injury to my personal property or of any bodily injury to me, including bodily injury resulting in death or permanent injury, as a result of an event held by the NTA North America's Richest Indian Rodeo, it's officers, directors, employees, agents, representatives, and it's sponsors, or against any NTA North America's Richest Indian Rodeo contestants, stock contractors, rodeo producers, bull fighters and other contract personnel. I do further release and discharge all of the above-mentioned persons and entities from any liability for any of the above-mentioned personal injuries and property damages which are incurred in connection with my participation in an event held by the NTA North America's Richest Indian Rodeo. I will not commence or prosecute any claim for damages against any of the persons or entities released, and if I bring or prosecute any claim in breach of this agreement, I will pay all costs and expenses caused by my breach or which are incurred in connection with the enforcement of this agreement, including a reasonable amount of attorneys fees, and abide by all rules of the NTA North America's Richest Indian Rodeo.

Assignment of Proprietary Rights and Release of Claims (FOIP)
